

The Board of County Commissioners, Highland County, Ohio, met this day in Regular Session with David Daniels, Brad Roades and Terry Britton present.

Mr. Daniels called the meeting to order at 9:00 a.m. All documents referenced in the minutes are filed in the Commissioners' office and are available for review upon request.

MOTION Mr. Roades moved, seconded by Mr. Britton, to approve the minutes from the previous meeting. The vote resulted as follows: Mr. Daniels, yea; Mr. Roades, yea; and Mr. Britton, yea.

MOTION Mr. Roades moved, seconded by Mr. Britton, to approve payment of Bill File No. 24-39. The total bill file amount paid was \$785,927.63. The total General Fund paid was \$22,084.55. The vote was as follows: Mr. Daniels, yea; Mr. Britton, yea; and Mr. Roades, yea.

MEETINGS/APPOINTMENTS

Ms. Dara Gullet came to the meeting to announce the upcoming Trivia Night Fundraiser that will include raffles, giveaways, and a dinner. Ms. Gullet also requested the marriage license fees for 2025 which brings them approximately \$8-9K per year from both Highland and Clinton counties.

Res No 24-174 Mr. Roades moved, seconded by Mr. Britton, Commissioners Declare State of Emergency Due to Drought. The vote was as follows: Mr. Daniels, yea; Mr. Britton, yea; and Mr. Roades, yea.

Commissioner Roades started out by saying that we are in a severe D4 drought. He explained that this would allow state funding to become more readily available. Currently USDA has funding for crop and animal farmers. Ohio Department of Agriculture has a Hay Directory available for both the producers and the consumers. EMA Director Dave Bushelman added that September 6th was when the burn ban was put in place. Shawn Atkins from the City of Hillsboro added that the City has 70 days water supply left, but they have tapped into the county water and he said they broke even yesterday.

Res No 24-175 Mr. Roades moved, seconded by Mr. Britton, Commissioners authorize Christopher M. Fauber Highland County Engineer to prepare and submit an application to participate in the Ohio Public Works Commission State Capital Improvement and or Local Transportation Improvement Programs and to execute contracts as required. Mr. Jared Warner announced some upcoming events through the Health Department including the Break for Breakfast event on October 1st, a Free Water Bottle Refilling Station with approximately 50 grants available, Solid Waste Dumpster Days on October 8th and 9th as well as October 29th, and then an upcoming Tire and Electronics Collection Event on September 28th.

Mr. Alex Butler reported on the Sales Tax numbers for September. The total was \$869,984.39 which was 4.9% higher than September last year and up 4.4% YTD.

Mr. Rayburn announced the upcoming Free Rides for election season. Those can be scheduled for early voting or the day of to your polling location. He also announced the upcoming Quarterly Transportation Advisory Meeting which will be held October 1st @ 3:00 p.m. and is open to the public.
